EXECUTIVE SUMMARY

The Fall 2008 headcount decreased 3.4% and the FTE increased 2.3%. Full-time headcount was up 14 students and part-time headcount was down 67 students resulting in a total decrease of 53 students. The number of students who attended EWC for the first time in Fall 2008 was down 17 full-time students and down 40 part-time students. The number of students who had attended EWC anytime prior to Fall 2008 was up 42 full-time students and down 30 part-time students. Goshen County was up 49 full-time and down 98 part-time students, and outreach decreased by 35 full-time and increased 31 part-time students. Goshen County FTE increased by 43.63 FTE, and outreach decreased by 20.07 FTE. Outreach accounted for 35% of the FTE.

Credit course offerings are provided as regular courses in both Goshen County and the 12 outreach sites. In addition, concurrent enrollment in the high schools, and distance learning courses are also offered. Outreach had 46.54% of its 375.11 FTE from concurrent enrollment courses. Goshen County courses generated 699.46 FTE of which 6.58% are from concurrent enrollment courses, 5.21% from evening courses, and 12.30% from distance education courses. Concurrent enrollment courses generated 55.89% of the 312.78 non-LEA (Wyoming Law Enforcement Academy) FTE from outreach. Please note that LEA credits have only been “countable” since Fall 2006.

One of the challenges in scheduling courses is determining the time and delivery method that will best serve the largest number of students and accommodate the needs of non-traditional and site bound students. EWC does not have an adequate number of instructors to also offer many of the distance learning and evening courses during the day in a regular classroom setting. Some of the on-campus day students enrolled in distance learning and/or evening courses may prefer to take the courses during the daytime in a regular course setting; however, that option is not always available. The 49 distance education courses served 125 students living in EWC's outreach areas and 107 students living in Goshen County for a total of 232 students. However, 104 (97.2%) of the 107 students in Goshen County were also enrolled in regular on-campus day courses. Similarly, the 18 on-campus credit evening courses served a total of 136 students with 99 (72.79%) of the students also enrolled in regular on-campus day courses.

Developmental courses are offered for those students who do not have college level skills in reading, writing, and mathematics. There were 127 students enrolled in developmental courses, which accounted for 4.43% of the FTE. Of the 127 students enrolled in developmental courses, 119 of those students are seeking an associate degree or certificate.

The total Fall 2008 headcount was 1,505 students. Of those students, 782 (51.96%) were non-degree seeking. The academic programs with the largest enrollments were Welding & Joining Technology, Interdisciplinary Studies, Pre-Nursing, and Veterinary Technology. Eastern Wyoming College provides numerous non-credit and workforce development offerings. EWC's non-credit enrollment was 1,195 students compared to 1,447 students in Fall 2007. EWC's workforce development efforts provided 52 credit courses totaling 108.54 FTE and 68 non-credit courses meeting for a total of 464.50 contact hours to provide further educational opportunities for individuals in or preparing to enter the workforce.

The Fall 2008 on-campus, full-time students came from 22 states and four foreign countries. Most of the students came from five states: Wyoming, Nebraska, Colorado, South Dakota, and Montana. Within Wyoming, the full-time, on-campus students came from 19 counties, with the majority coming from Goshen, Laramie, Platte, and Crook. The gender distribution for all credit students was 40% male and 60% female. The ethnicity distribution was 92% white non-Hispanic, 4% Hispanic, and 4% all others. The average age of students enrolled in credit courses was 28 with a 22 average for full-time students and a 31 average for part-time students.

There are numerous ways to analyze EWC's enrollment trends and student population and there are many factors, both internal and external, which affect enrollment trends. We have no control over the external factors, which include the state of the economy, the unemployment rate and the number of high school graduates. In any given year, there are many factors which may have affected the increase or decrease in enrollment.

EWC experienced a 3.4% decrease in total student headcount as compared to Fall 2007. The total student headcount of 1,505 students reflects an overall decrease of 53 students. Not including LEA, total fulltime enrollment is 27.2 students above the five-year average and total part-time enrollment is 47.8 students below the five-year average for a total of 20.6 students below the five-year average.

EWC experienced a 2.3% increase in FTE compared to Fall 2007. Not including LEA, the FTE is 28.9 above the 5 year average.

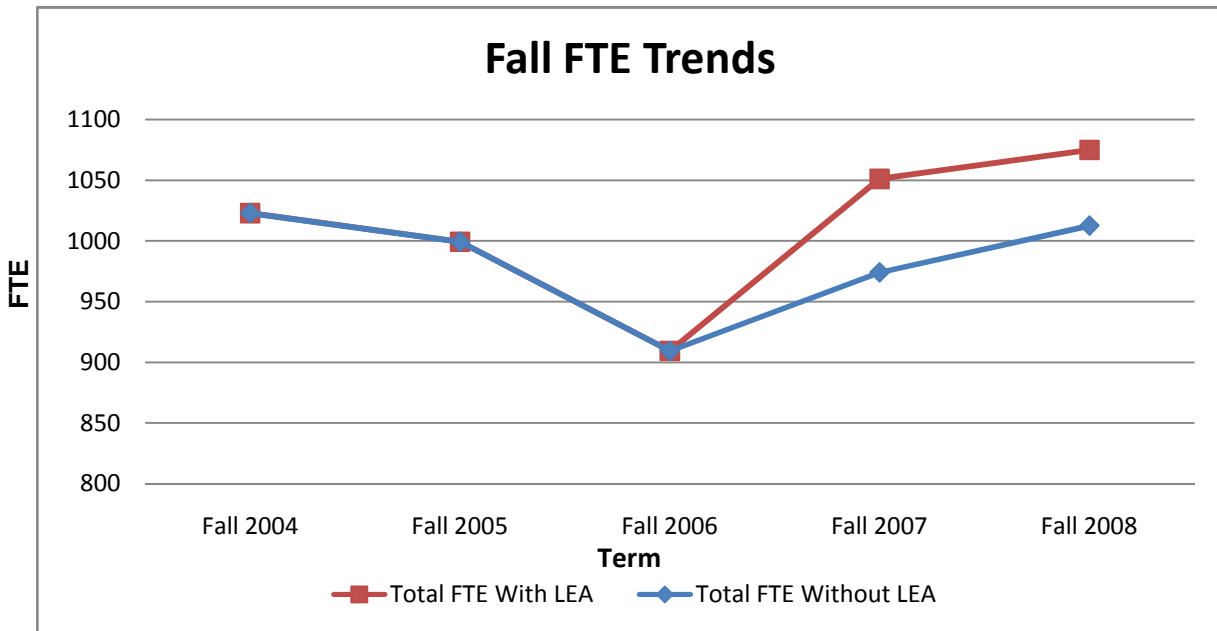
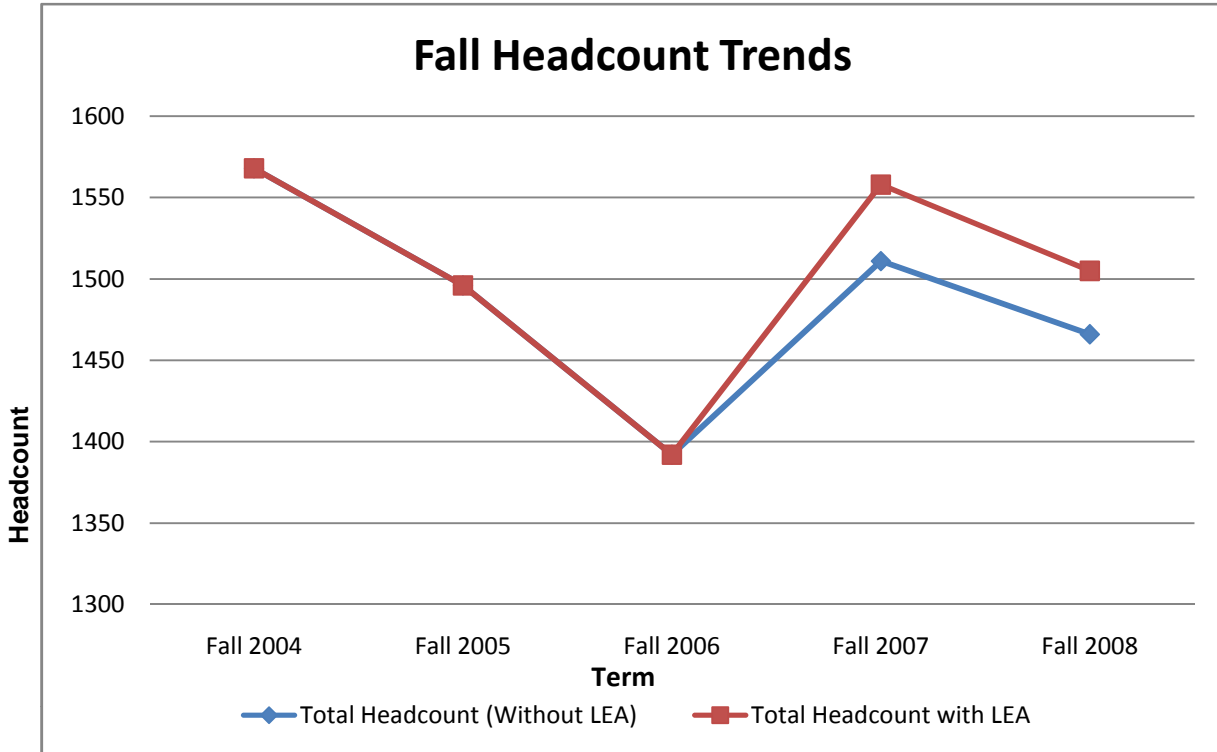

FALL FULL-TIME HEADCOUNT

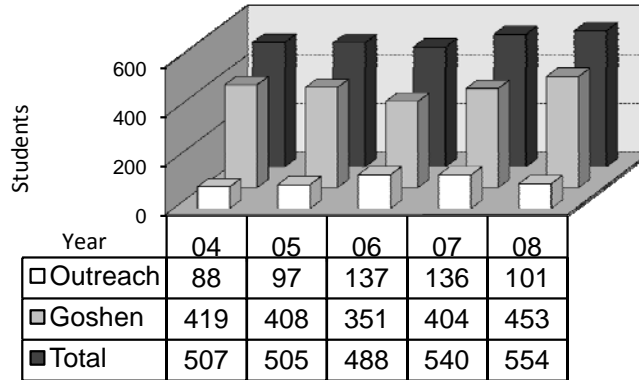
EWC experienced a decrease of 35 (25.5%) full-time students in Outreach enrollment and an increase of 49 (14.0%) students in Goshen County for a total increase of 14 (2.9%) students as compared to Fall 2007. Outreach full-time headcount was 11 below the five-year average. Goshen County was 46 above the five-year average for an overall 35 students above the five-year average.

FALL PART-TIME HEADCOUNT

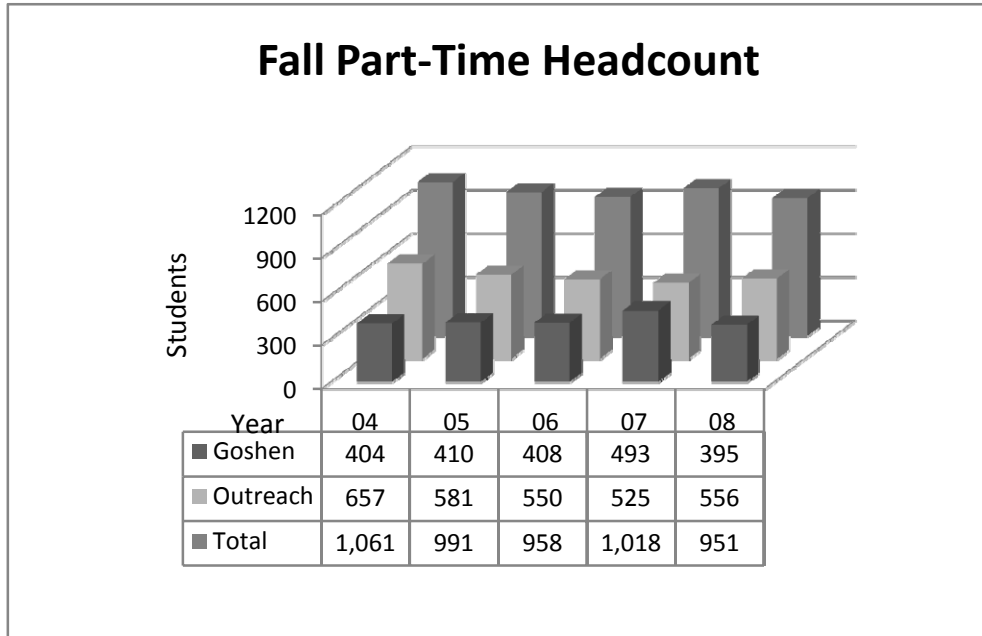
EWC experienced an increase of 31 (5.9%) part-time students in outreach enrollment and a decrease of 98 (19.9%) students in Goshen County for a total decrease of 67 (6.6%) students as compared to Fall 2007. Fall 2008 outreach part-time headcount was 18 students below the five-year average, and Goshen County part-time headcount was 27 below the five-year average. The total part-time headcount was below the five-year average by 45 students.

FALL HEADCOUNT BY AGE

The two highest enrollments by age group were the 17-24 age group with 55.1% of the enrollment and 16 or younger with 9.8% of the enrollment. The most significant changes were a decrease of 31 (4 full-time and 27 part-time) students in the 50-59 age group and a decrease of 28 students in the 40-49 age group. The greatest impact on EWC enrollment based on age is the decrease in traditional age students. The non-traditional age group (25 and older) has decreased by 47 students.

EWC experienced an increase in the number of students less than age 25 in outreach by 13 (3.1%) students and a decrease of 16 (2.9%) students in Goshen County for a total decrease of 3 (0.3%) students less than age 25. Outreach had a decrease of 17 (7.2%) students age 25 and older, and Goshen County experienced a decrease of 33 (9.7%) students age 25 and older. The Wyoming Law Enforcement Academy had 10 students less than age 25 and 29 students age 25 or older.

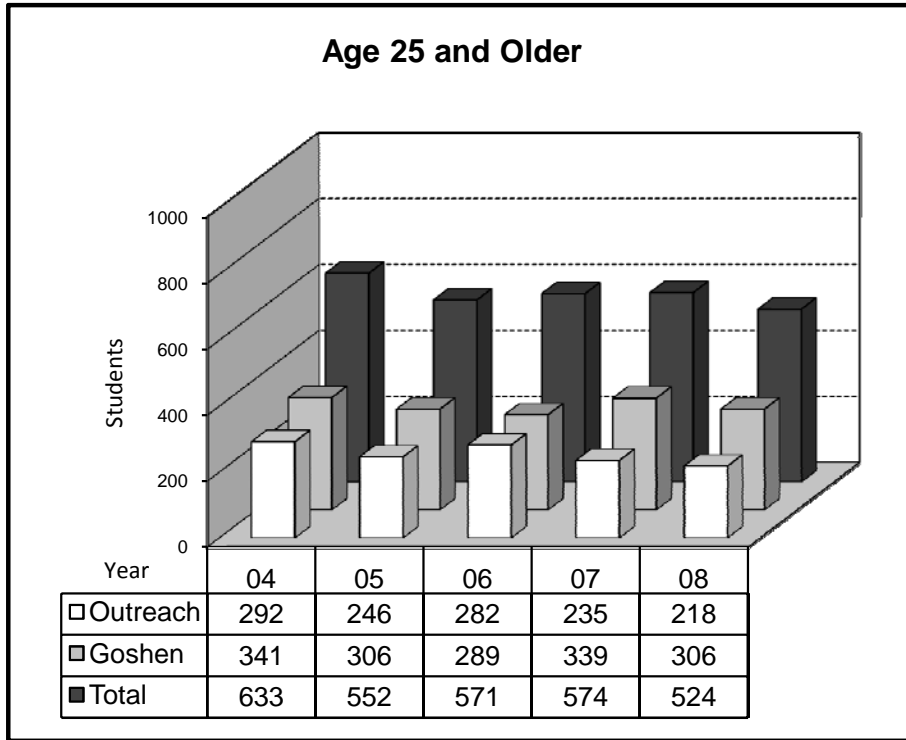
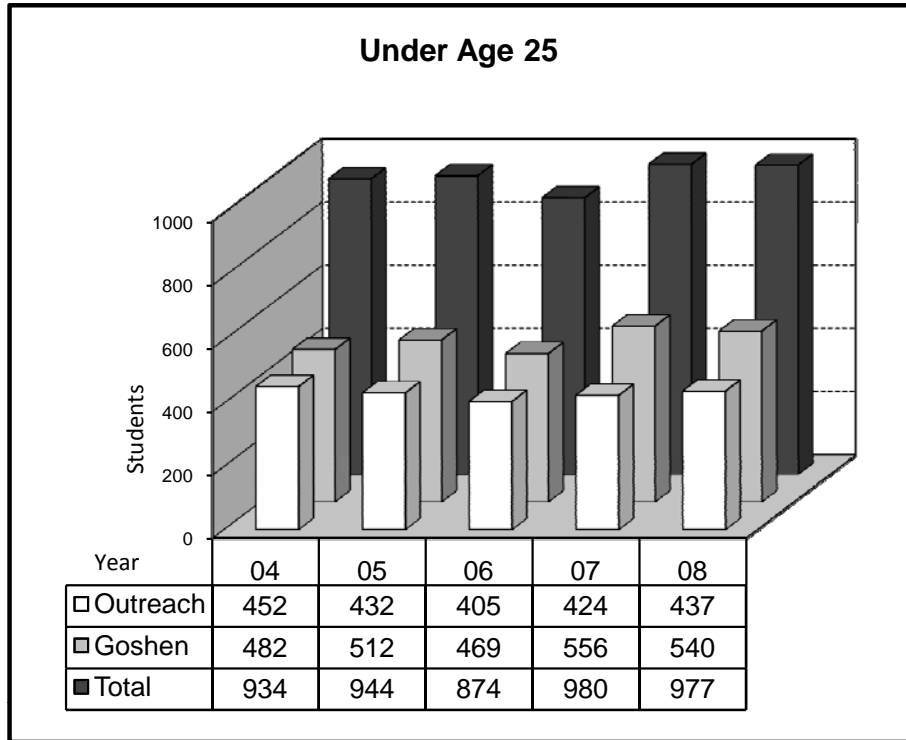

FALL AGE UNDER 25/AGE 25 AND OLDER



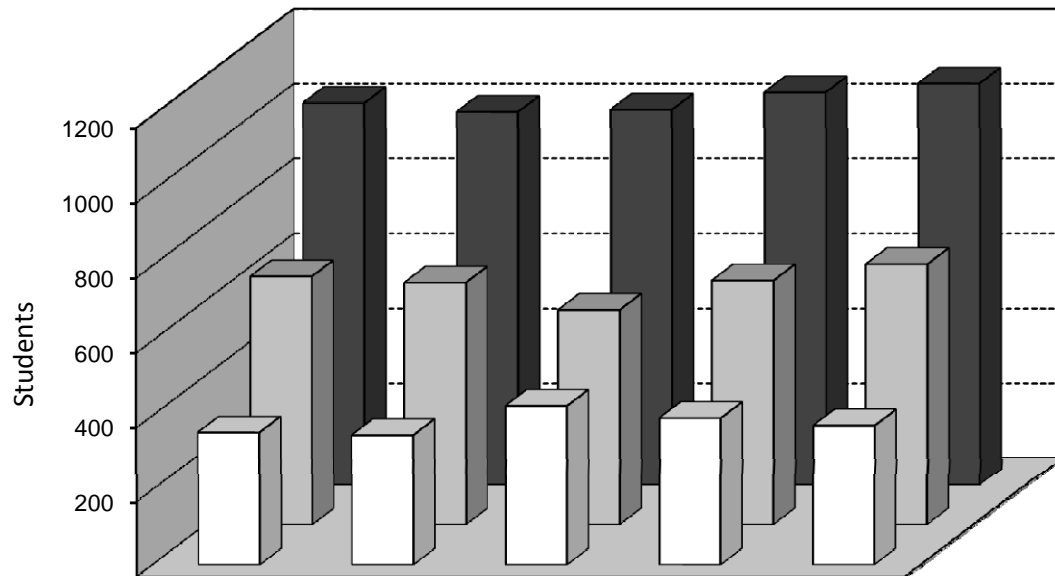
FALL FTE BY LOCATION

FALL FTE BY STUDENT LOCATION

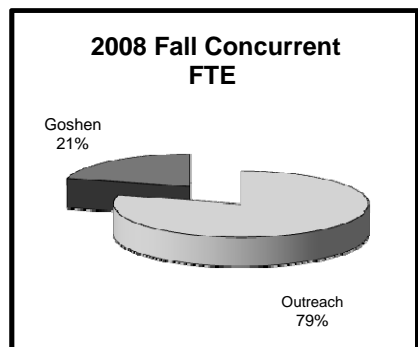
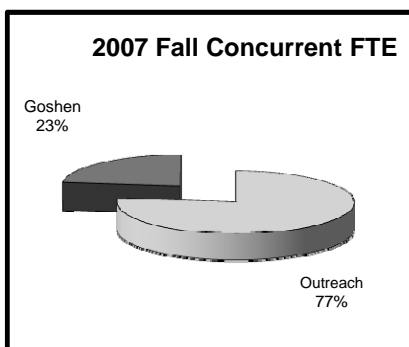
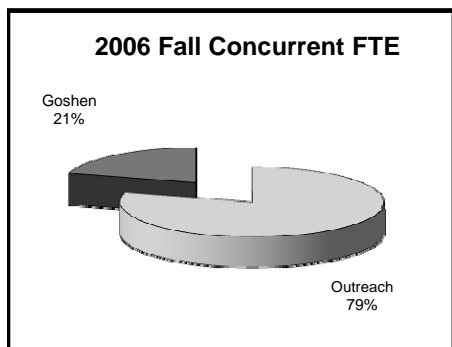
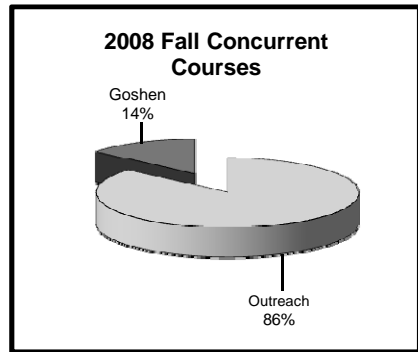
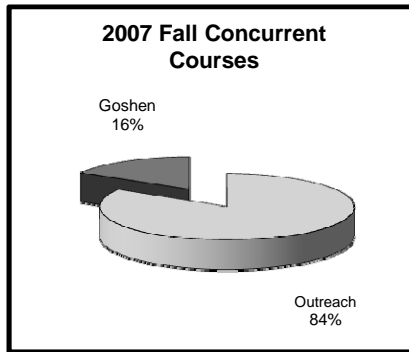
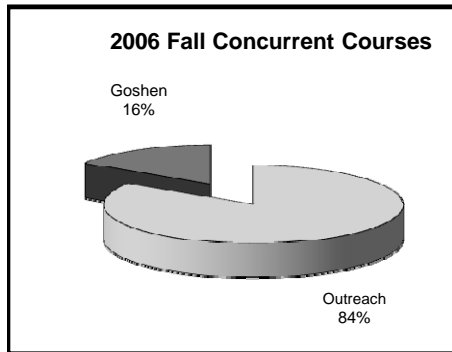

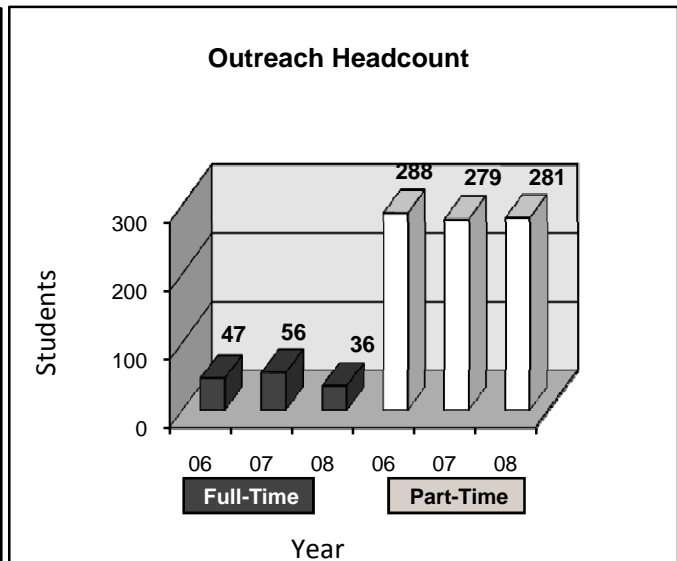
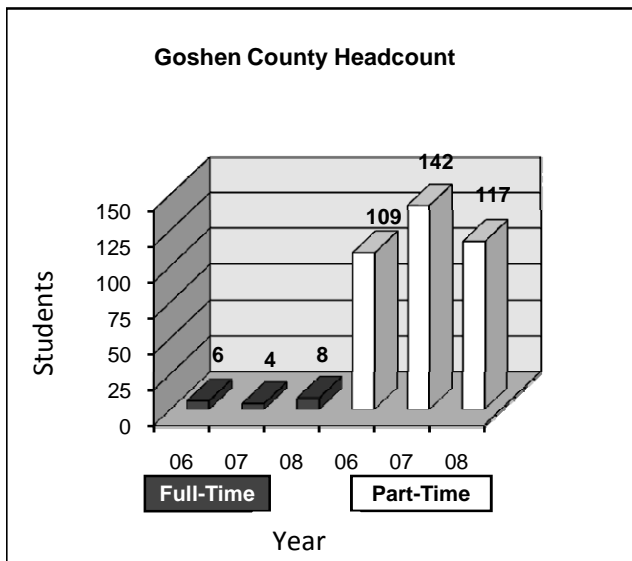


FALL HIGH SCHOOL STUDENT HEADCOUNT

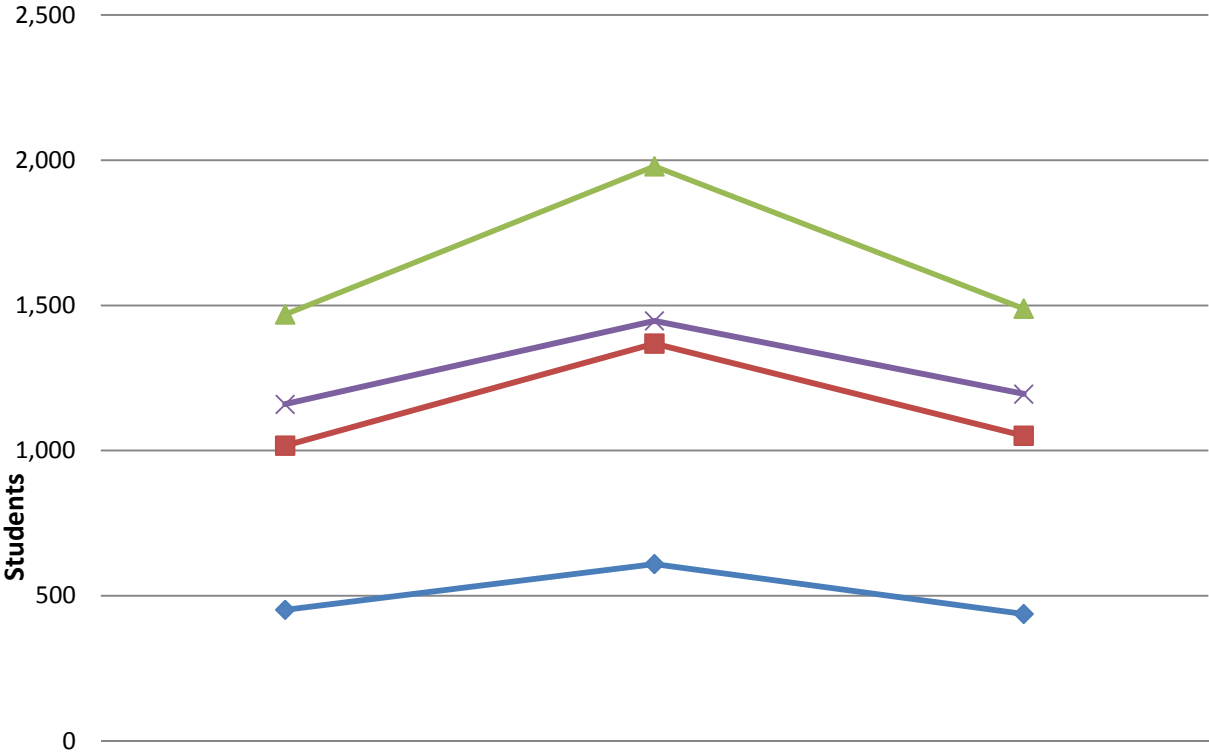

EWC's workforce development offerings for college credit decreased by 9 course sections compared to Fall 2007. The duplicated student headcount decreased by 163 (23.52%) students, and the FTE decreased by 14.13 (11.52%) FTE.
