## SELECTIVE SERVICE INFORMATION

Federal and some State laws require registration-age males applying for certain benefits (such as student financial aid, government employment, U.S. citizenship, and job training) to be registered with Selective Service. In addition to being subject to prosecution, failure to register may cause you to permanently forfeit eligibility for these benefits, as men cannot register after reaching age 26.

In order to receive federal student aid, you must be registered with Selective Service if you are a male who is at least 18 years old and born after December 31, 1959. If you are a male and are 18-25 years of age, have not yet registered with Selective Service and give Selective Service permission to register you, you must complete the Selective Service registration form, which you can pick up at any U.S. Post Office. You may also register online via your FAFSA at [fafsa.gov](http://fafsa.gov) or via the Selective Service website at [sss.gov](http://sss.gov).

Your financial aid cannot be finalized if you are not registered with the Selective Service.

Please check the appropriate response:
