EXECUTIVE SUMMARY

The Fall 2018 headcount decreased 4.8% and the FTE decreased 2.6% compared to Fall 2017. Full-time headcount was down 3 students and part-time headcount was down 77 students resulting in a total decrease of 80 students. The number of students who attended EWC for the first time in Fall 2018 was up 26 full-time students and down 96 part-time students. The number of students who had attended EWC any time prior to Fall 2018 was down 29 full-time students and up 19 part-time students. Goshen County was down 39 full-time and down 21 part-time students, and Outreach increased by 36 full-time and decreased by 56 part-time students. Goshen County FTE decreased by 50.50 FTE, and Outreach increased by 20.83 FTE. Outreach accounted for 43.8% of the FTE.

Credit course offerings are provided as regular courses in both Goshen County and most of the 12 outreach sites. In addition, concurrent enrollment in the high schools, and distance learning courses are also offered. Goshen County courses generated 618.17 FTE of which 4.49% were from concurrent enrollment courses, 4.76% from evening courses, and 28.27% from distance education courses. Concurrent enrollment courses generated 55.47% of the 481.08 FTE from Outreach.

One of the challenges in scheduling courses is determining the time and delivery method that will best serve the largest number of students and accommodate the needs of non-traditional and site bound students. Some of the on-campus day students do enroll in distance learning and/or evening courses. The 115 distance education courses served 201 students living in EWC's outreach areas and 245 students living in Goshen County for a total of 446 students. However, 177 (72.2%) of these 245 students in Goshen County were also enrolled in regular on-campus day courses. Similarly, the 21 on-campus credit evening courses served a total of 114 students with 104 (91.2%) of these students also enrolled in regular on-campus day courses.

Developmental courses are offered for those students who do not have college level skills in reading, writing, and mathematics. There were 124 students enrolled in developmental courses, which accounted for 3.29% of the FTE. Of the 124 students enrolled in developmental courses, 77 of those students are seeking an associate degree or certificate.

The total Fall 2018 headcount was 1572 students. Of those students, 1022 (65.0%) were non-degree seeking. High School students accounted for 718 (70.3%) students of the 1022 non-degree seeking students. The programs with the largest enrollments were Interdisciplinary Studies, Welding & Joining Technology, and Veterinary Technology.

Eastern Wyoming College provides numerous non-credit and Workforce Development offerings. EWC's non-credit enrollment was 594 students compared to 561 students in Fall 2017. EWC's Workforce Development efforts provided 39 credit courses totaling 84.58 FTE and 7 non-credit courses meeting for a total of 80.00 contact hours to provide further educational opportunities for individuals in or preparing to enter the workforce.

The Fall 2018 full-time students came from 19 states and foreign countries. Most of the students came from 4 states: Wyoming, Nebraska, Colorado and South Dakota. Within Wyoming, the full-time students came from 21 counties, with the majority coming from Goshen, Converse, Platte, Laramie, and Crook.

The gender distribution for all credit students was 44.1% male and 55.9% female. The ethnicity distribution was 86.3% white non-Hispanic, 8.7% Hispanic, and 5.0% all others. The average age of students enrolled in credit courses was 23.9 with a 20.3 average for full-time students and a 25.8 average for part-time students.

EWC Final Enrollment Fall 2018

EWC experienced a decrease of 80 students (-4.8%) in total headcount as compared to Fall 2017. The total student headcount was 1572. The full-time enrollment went down 3 students and the part-time enrollment went down 77 students compared to Fall 2017. The enrollment in Fall 2018 was 149.2 below the 5 year average.

EWC experienced a decrease of 2.6% in FTE compared to Fall 2017. The FTE was 109.3 below the 5 year average.

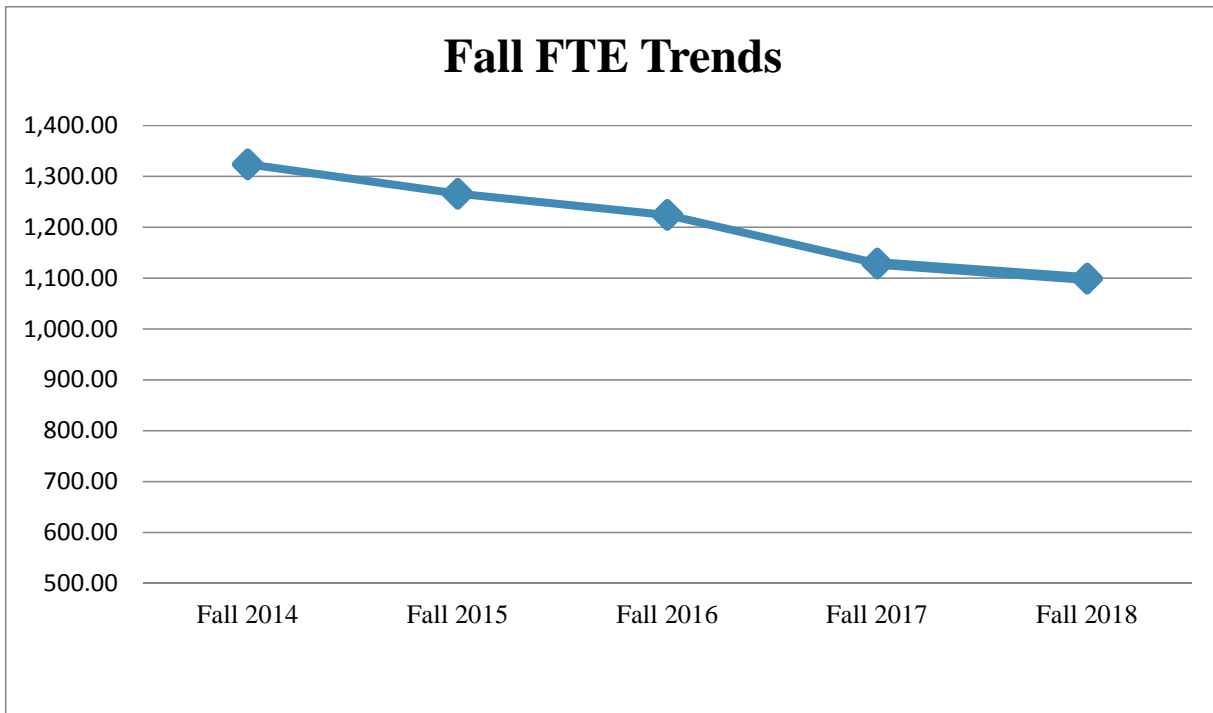
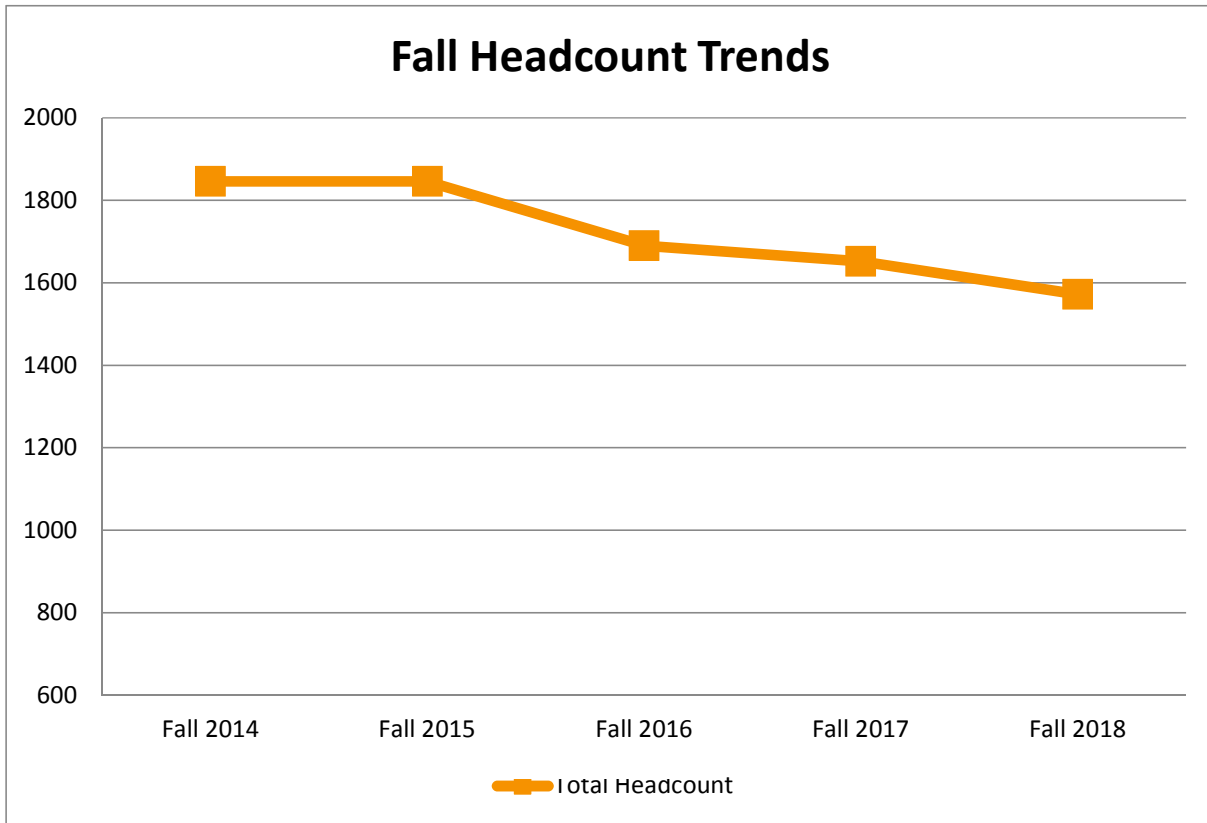

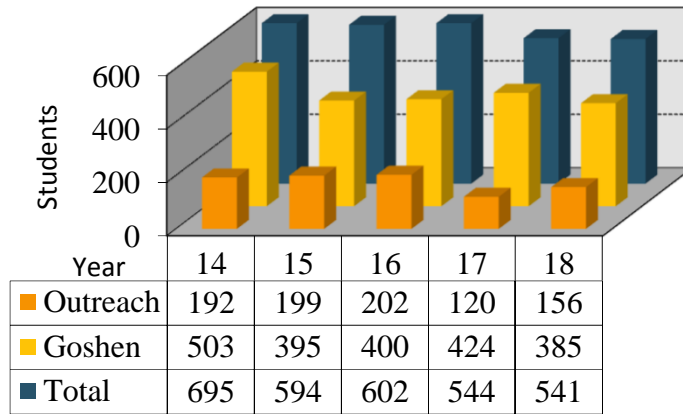
FALL FULL-TIME HEADCOUNT

Outreach full-time headcount was 17.8 below the 5 year avg. Goshen County was 36.4 below the 5 year avg for an overall 54.2 below the 5 year avg.

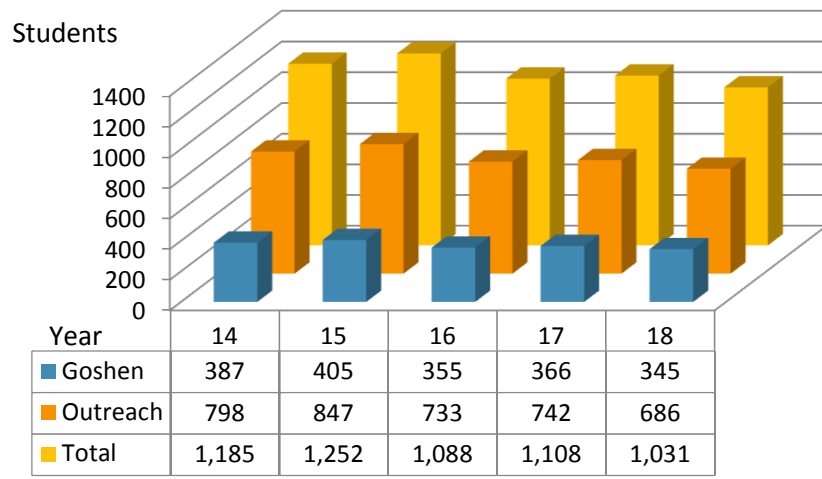
FALL PART-TIME HEADCOUNT

The part-time enrollment growth in Outreach was -56 (-7.5%) and in Goshen County it was -21 (-5.7%). The total part-time growth was -77 (-6.9%) as compared to last Spring. Outreach part-time headcount was 75.2 below the 5 yr avg and the Goshen County part-time headcount was 26.6 below the 5 yr avg. The total part-time headcount was 101.8 below the 5 yr avg.

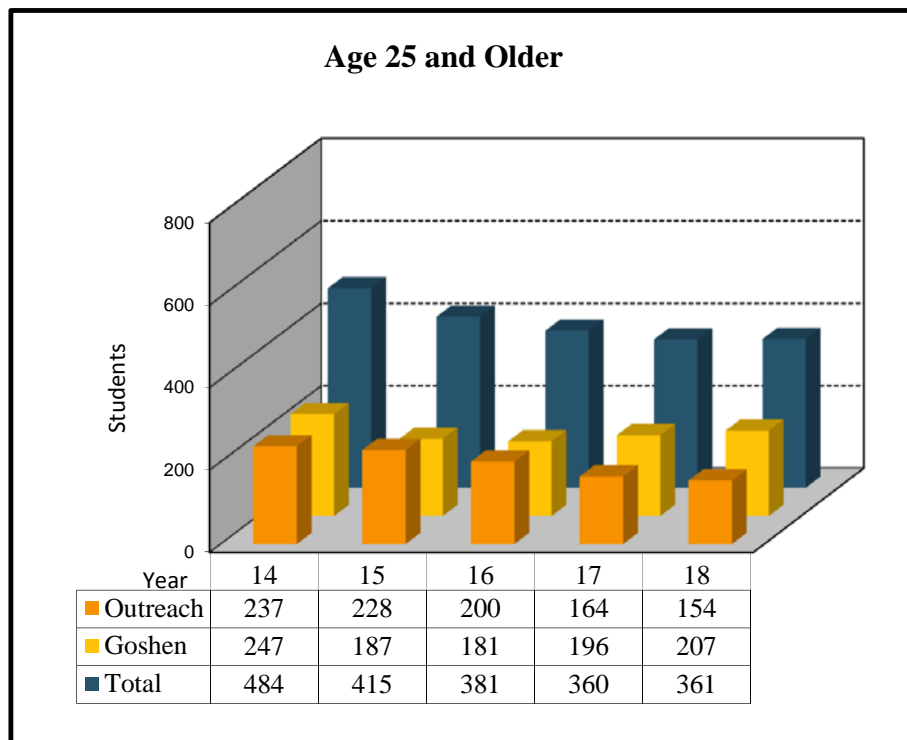
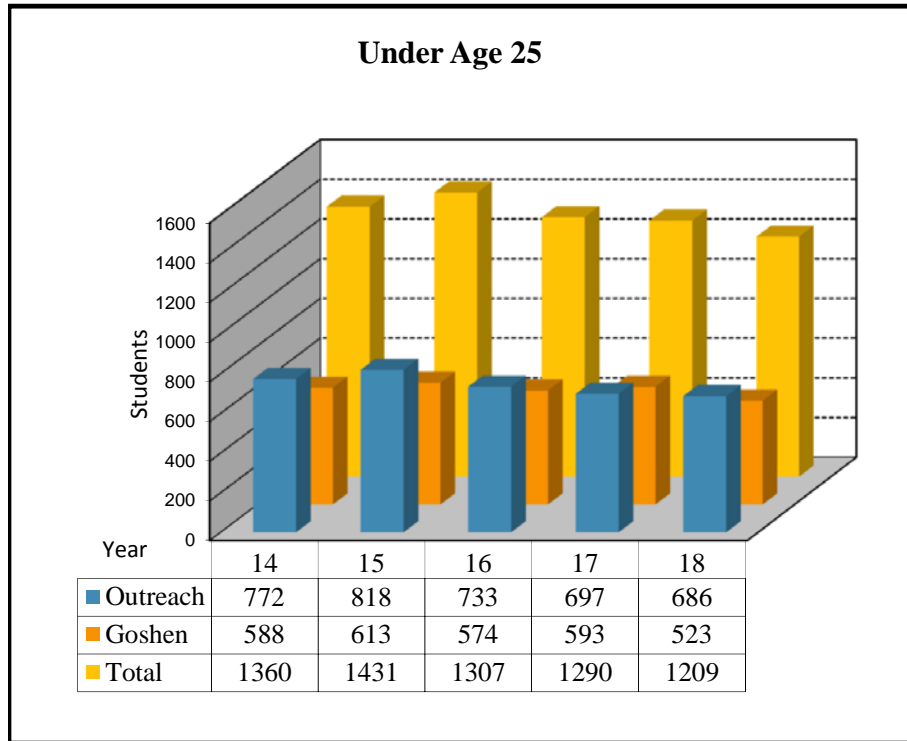

FALL AGE UNDER 25/AGE 25 AND OLDER



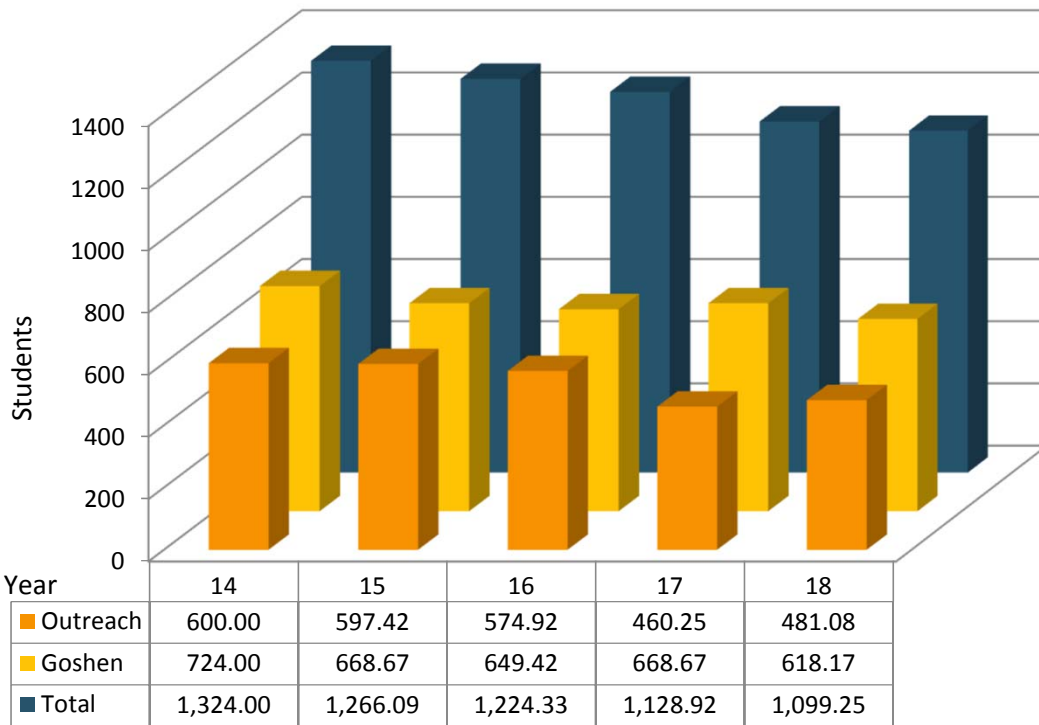
FALL FTE BY LOCATION

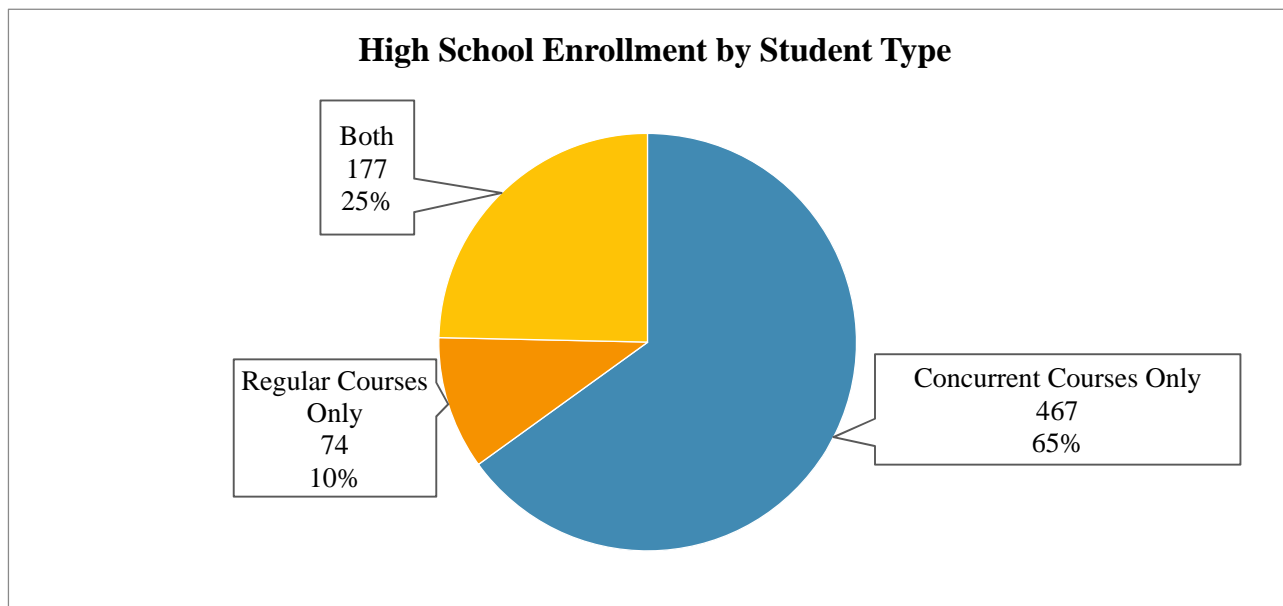

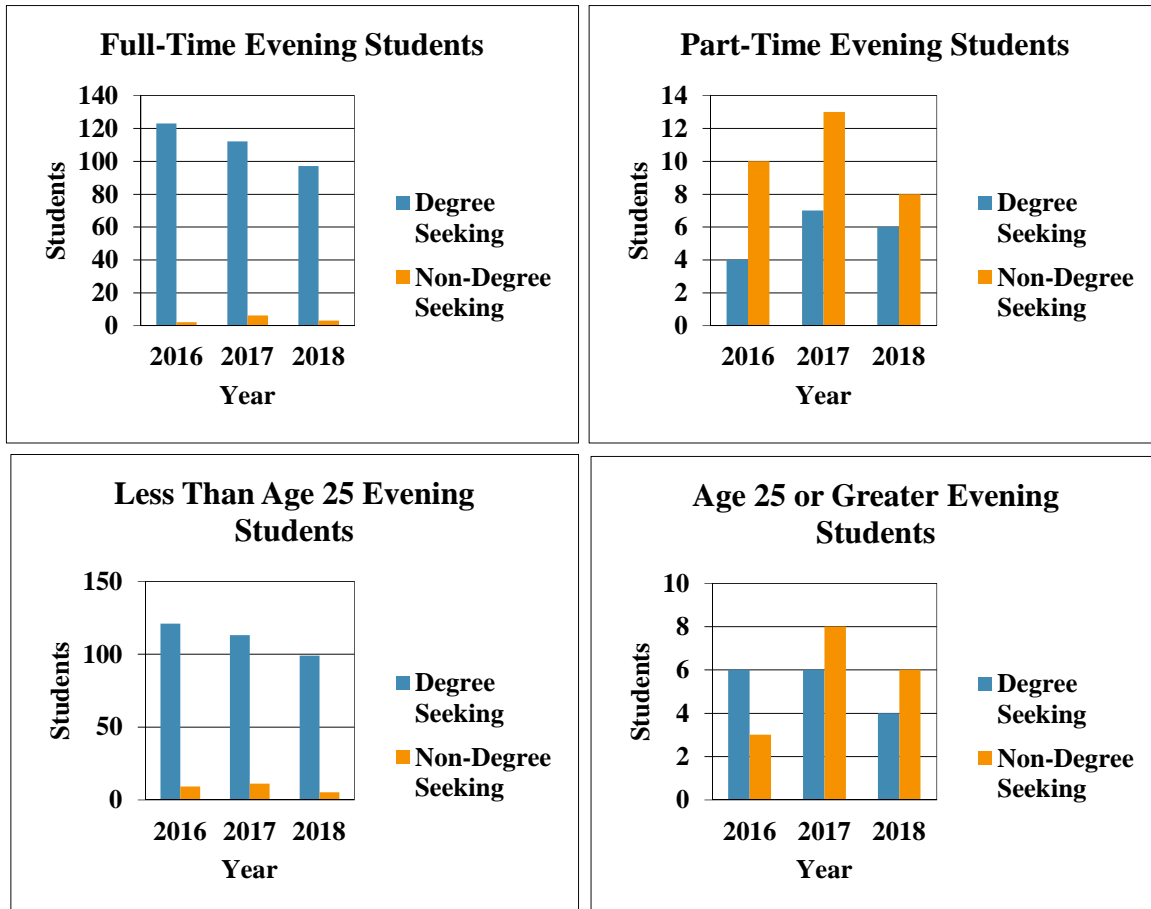
