NCLEX Pass Rates

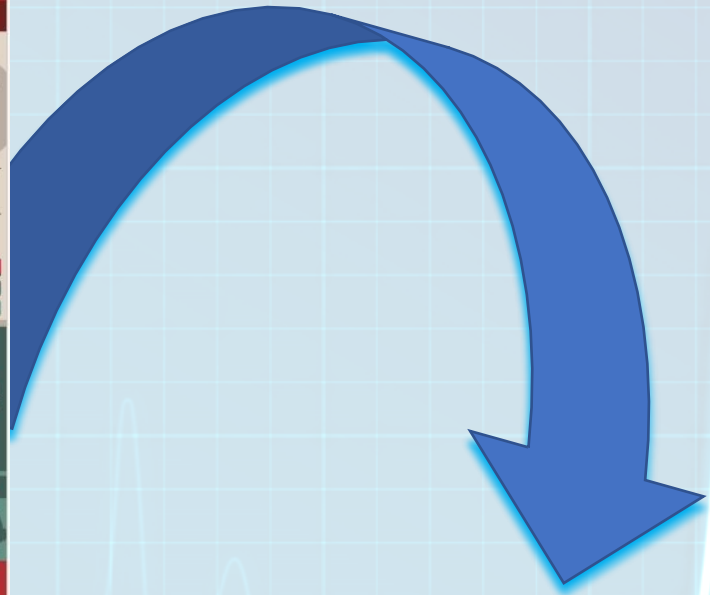
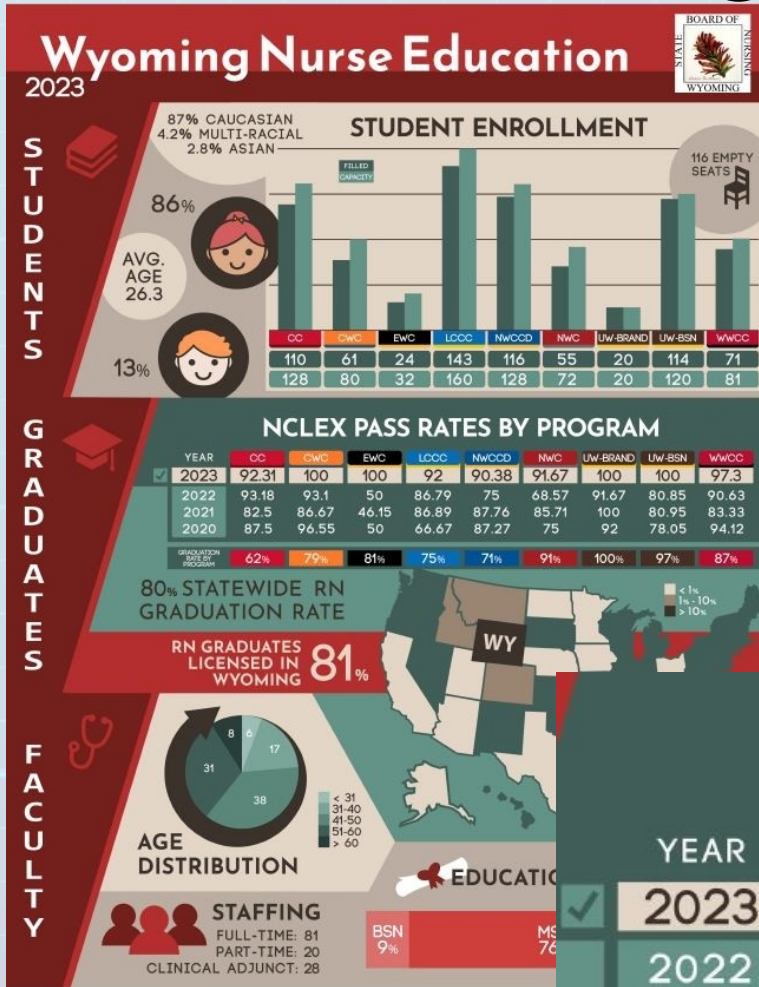

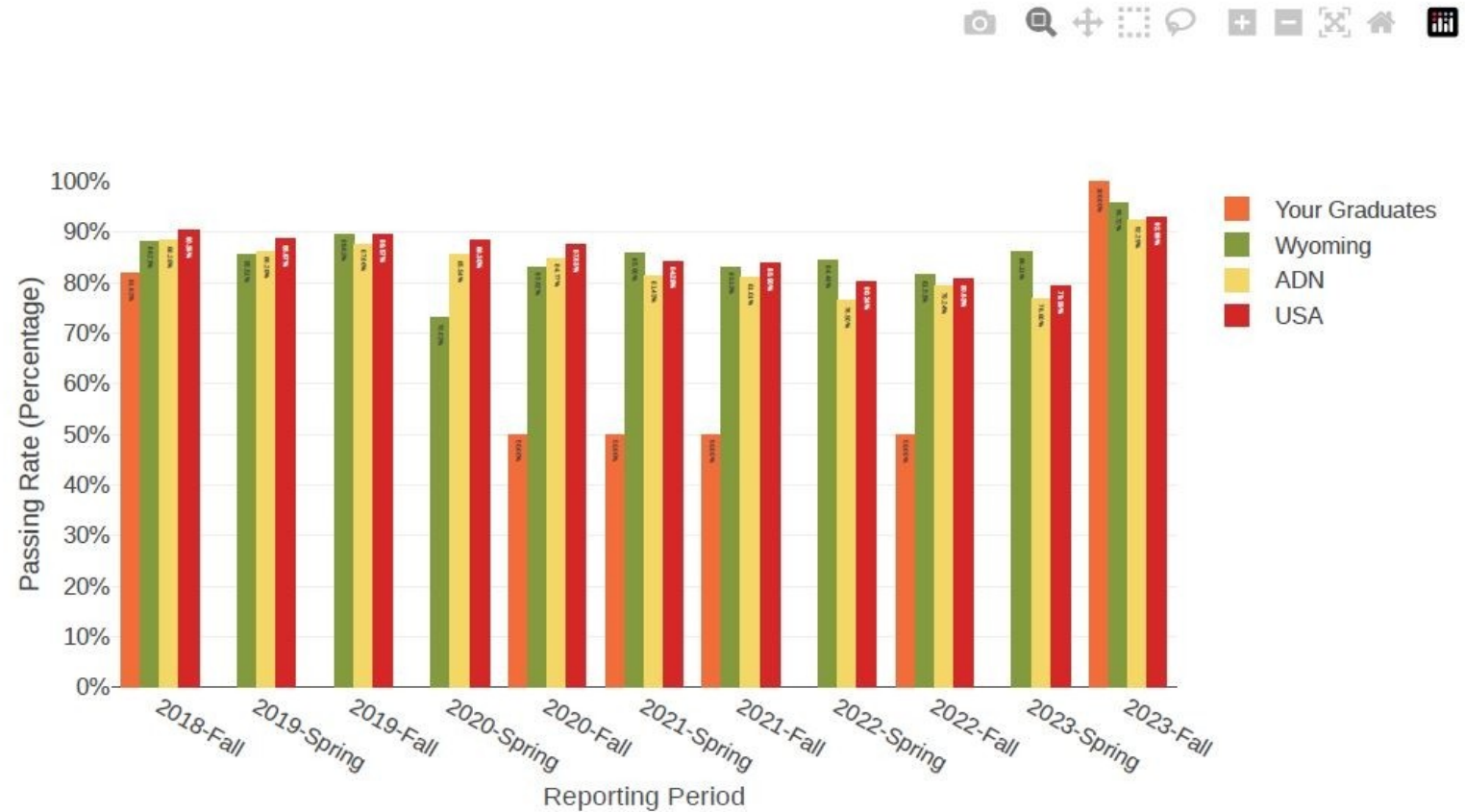

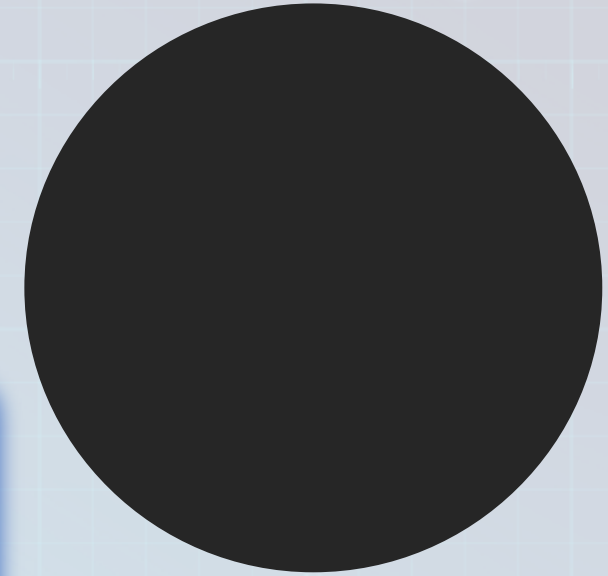

Headcount Summary:

The Day One 2024 Spring Semester Headcount (1/16/2024) for degree-seeking students at Eastern Wyoming College was 409 students for all locations. This was 6% lower as compared to the Spring 2023 Day One Headcount (435), 7% lower as compared to the Spring 2022 Day One Headcount (439), and 28% lower as compared to the Spring 2020 Day One Headcount (524).

The Torrington Campus Day One 2024 Spring Semester Headcount (1/16/2024) for degree-seeking students was 324 students. This was 4% lower as compared to the Spring 2023 Day One Headcount (337), 2% lower as compared to the Spring 2022 Day One Headcount (329), and 22% lower as compared to the Spring 2020 Day One Headcount (395).

The Douglas Campus Day One 2024 Spring Semester Headcount (1/16/2024) for degree-seeking students was 63 students. This was 11% lower as compared to the Spring 2023 Day One Headcount (70), 5% lower as compared to the Spring 2022 Day One Headcount (66), and 46% lower as compared to the Spring 2020 Day One Headcount (92).

The Outreach Campuses Day One 2024 Spring Semester Headcount (1/16/2024) for degree-seeking students was 20 students. This was 35% lower as compared to the Spring 2023 Day One Headcount (27), 70% lower as compared to the Spring 2022 Day One Headcount (34), and 70% lower as compared to the Spring 2020 Day One Headcount (34).

Due to the small sample size of the Other Locations (Wyoming Medium Correctional Center, Out-of-state Distance Learners), headcount results were not disaggregated.

Credit Count Summary:

The Day One 2024 Spring Semester Credit Count (1/16/2024) for degree-seeking students at Eastern Wyoming College was 5,495 credits for all locations. This was 6% lower as compared to the Spring 2023 Day One Credit Count (5,820), 73% lower as compared to the Spring 2022 Day One Credit Count (5,652), and 22% lower as compared to the Spring 2020 Day One Credit Count (6,722).

The Torrington Campus Day One 2024 Spring Semester Credit Count (1/16/2024) for degree-seeking students was 4,646 credits. This was 6% lower as compared to the Spring 2023 Day One Credit Count (4,923), comparable to the Spring 2022 Day One Credit Count (4,627), and 19% lower as compared to the Spring 2020 Day One Credit Count (5,539).

The Douglas Campus Day One 2024 Spring Semester Credit Count (1/16/2024) for degree-seeking students was 676 credits. This was 7% lower as compared to the Spring 2023 Day One Credit Count (722), 9% lower as compared to the Spring 2022 Day One Credit Count (734), and 23% lower as compared to the Spring 2020 Day One Credit Count (832).

The Outreach Campuses Day One 2024 Spring Semester Credit Count (1/16/2024) for degree-seeking students was 152 credits. This was 9% lower as compared to the Spring 2023 Day One Credit Count (166), 57% lower as compared to the Spring 2022 Day One Credit Count (238), and 114% lower as compared to the Spring 2020 Day One Credit Count (326).

Due to the small sample size of the Other Locations (Wyoming Medium Correctional Center, Out-of-state Distance Learners), credit count results were not disaggregated.

Headcount Summary:

The Day 10 2024 Spring Semester Headcount (1/24/2024) for degree-seeking students at Eastern Wyoming College was 414 students for all locations. This was 7% lower as compared to the Spring 2023 Day 10 Headcount (442), 7% lower as compared to the Spring 2022 Day 10 Headcount (445), and 26% lower as compared to the Spring 2020 Day10 Headcount (521).

The Torrington Campus Day 10 2024 Spring Semester Headcount (1/24/2024) for degree-seeking students was 331 students. This was 4% lower as compared to the Spring 2023 Day 10 Headcount (343), 2% lower as compared to the Spring 2022 Day 10 Headcount (336), and 20% lower as compared to the Spring 2020 Day10 Headcount (397).

The Douglas Campus Day 10 2024 Spring Semester Headcount (1/24/2024) for degree-seeking students was 61 students. This was 15% lower as compared to the Spring 2023 Day 10 Headcount (70), 13% lower as compared to the Spring 2022 Day 10 Headcount (69), and 51% lower as compared to the Spring 2020 Day10 Headcount (92).

The Outreach Campuses Day 10 2024 Spring Semester Headcount (1/24/2024) for degree-seeking students was 20 students. This was 35% lower as compared to the Spring 2023 Day 10

Headcount (27), 55% lower as compared to the Spring 2022 Day 10 Headcount (31), and 45% lower as compared to the Spring 2020 Day One Headcount (29).

Due to the small sample size of the Other Locations (Wyoming Medium Correctional Center, Out-of-state Distance Learners), headcount results were not disaggregated.

Credit Count Summary:

The Day 10 2024 Spring Semester Credit Count (1/24/2024) for degree-seeking students at Eastern Wyoming College was 5,582 credits for all locations. This was 8% lower as compared to the Spring 2023 Day 10 Credit Count (6,009), 3% lower as compared to the Spring 2022 Day 10 Credit Count (5,766), and 20% lower as compared to the Spring 2020 Day10 Credit Count (6,690).

The Torrington Campus Day 10 2024 Spring Semester Credit Count (1/24/2024) for degree-seeking students was 4,751 credits. This was 6% lower as compared to the Spring 2023 Day 10 Credit Count (5,004), comparable to the Spring 2022 Day10 Credit Count (4,736), and 17% lower as compared to the Spring 2020 Day 10 Credit Count (5,576).

The Douglas Campus Day 10 2024 Spring Semester Credit Count (1/12/2024) for degree-seeking students was 645 credits. This was 22% lower as compared to the Spring 2023 Day 10 Credit Count (787), 19% lower as compared to the Spring 2022 Day 10 Credit Count (767), and 29% lower as compared to the Spring 2020 Day 10 Credit Count (831).

The Outreach Campuses Day 10 2024 Spring Semester Credit Count (1/12/2024) for degree-seeking students was 161 credits. This was 3% lower as compared to the Spring 2023 Day 10 Credit Count (166), 35% lower as compared to the Spring 2022 Day 10 Credit Count (218), and 60% lower as compared to the Spring 2020 Day10 Credit Count (258).

Due to the small sample size of the Other Locations (Wyoming Medium Correctional Center, Out-of-state Distance Learners), credit count results were not disaggregated.
