IV. Veterinary Technology Accreditation Affirmation Celebration: Dr. Colleen Mitchell

Dr. Mitchell presented a PowerPoint presentation on the process for the Veterinary Technology Accreditation and the Veterinary Technology department. Veterinary students and staff introduced themselves. Dr. Mitchell expressed some of the needs for the Vet Tech Department, i.e. new restrooms in the building, staffing needs for full time Veterinarians and ultimately, a new Vet Tech Building, as requested in the Facility Master Plan.

V. GEAR UP Program Update: Ms. Chelsea Ballard, GEAR UP Director

Ms. Ballard presented a PowerPoint presentation on the EWC GEAR UP Program. Currently, there are 337 students served to date. The program has regained its momentum and goals of growing the program in the fall semester to hit grant objectives before December 2024, recruiting "rising 6th graders" to offset seniors who are graduating and create a pipeline of GEARUP students to attend EWC annually.

VI. Civic Ready (replacing Code Red) - Update on Services from Goshen County Emergency Management: Mr. Thomas Bozeman, Coordinator and Ms. Tami Afdahl

Mr. Bozeman and Ms. Afdahl presented information on a new program, Civic Ready, which is going to take the place of the current system, Code Red. The idea is to coordinate with the City, County and College for the emergency notification system. There is a significant savings from \$603 for Code Red vs.

the Civic Ready price of \$375. Civic Ready (Plus) will be instigated at the end of this month, with an eight week implementation period. There will be a few months of overlapping with Code Red.
